### Editing and proofreading services

My core services are:

- **Copy-editing:** Preparing a manuscript for typesetting – checking that the spelling, grammar and punctuation are consistent and follow suitable conventions; ensuring clarity and compliance with required style.
- **Proofreading:** Checking a typeset proof for any remaining problems with the text, and for typesetting errors.
- **Business editing:** Checking that a business's written material is grammatically sound, consistent, clear, readable and suited to its target audience; this can include editing into plain English if needed.
- **Document assessment:** High-level reviewing of a document at an early stage in its development, and reporting on suggested enhancements.
- **Style guide development:** Writing or enhancing a set of guidelines to help establish a consistent style in an organisation's written material.

I've worked for a range of clients including publishing companies; marketing, communications and PR agencies; an IT consultancy; other businesses of various kinds; researchers; and independent authors.

I can edit or proofread almost any kind of written material, for example: books, reports, newsletters, magazines, website content, business documents and academic/research papers. My methods are flexible, and are tailored to suit each client and their specific needs for each job. I can work with both Word and PDF documents.

I'm an Advanced Professional Member of the Chartered Institute of Editing and Proofreading (CIEP), and am committed to follow its code of practice, [Ensuring Editorial Excellence](#), which assures high standards of editorial work and customer care.
